CITIZENS COMMITTEE FOR EVALUATION OF JUDGES

October 18, 1984

The October 18, 1984 meeting of the Citizens Committee for Evaluation of Judges was called to order at 7:40 P.M. Committee members present were: Robert Clark, Richard Eason, and Charles McClure. Committee Resource Group members in attendance were: Flodie Anderson, John Koops, Al Kullas and Keith Stott, Deputy State Court Administrator.

Charles McClure reported that he contacted the Chairman of the Arapahoe County Republican party in regard to distribution of the recommendations of the committee. Although they declined the request there was an expression of interest in working with the Citizens Committee in the future.

Charles McClure will determine if it is possible to get an 8 X 11 flyer produced. John Koops reported that he had contacted civic groups and teacher groups and four of them were willing to distribute flyers if we could make them available. Al Kullas will contact Anita Krumenacker on distribution. Bob Clark indicated he would be able to distribute some to churches.


Al Kullas will contact the Rocky Mountain News in regard to publication of information on the recommendations made by the Committee. Charles McClure will contact the Littleton Independent and ask Don Forst to contact the Denver Post. Charles will poll members of the committee on the possibility of purchasing an ad if we are unable to get news coverage.

The Committee discussed at some length the future of the judicial evaluation process. It was emphasized that it be an on-going process and that data essential for the evaluation should be gathered and stored. A judicial evaluation committee could then make an analysis of the data as a basis for their recommendation and spend much less time on process. Charles McClure will continue to pursue this matter with Greg Langham.

Keith Stott was in attendance and shared his particular interest in the work of the Committee. It was decided that Keith should attend our meeting on November 12, 1984. At this meeting he will explore the process of the committee in regard to background and purpose and make suggestions for refinement. Hopefully from this a publication would be produced regarding the methodology and how it might be applied in other judicial districts.
